Are Your Beneficiary Designations Current?

When was the last time you checked your beneficiary designations? You may designate a beneficiary(s) and contingent beneficiary(s) for your retirement benefit. If you name more than one beneficiary and one contingent beneficiary, you will need to indicate the specific percentage to be paid to each. A contingent beneficiary will receive your death benefit only if all the beneficiaries die before you. You can change your beneficiary designations at any time before retirement. We will be happy to provide you a copy of your current beneficiary form on file with GRS or you can check your beneficiaries on MemberDirect. Marriage, divorce, birth of a child, or death of a loved one are common reasons why you may need to revise your beneficiary form. Members wishing to change, add, or delete beneficiaries must complete a new [Beneficiary Designations Prior To Retirement](#) form which is available on our website, www.grsal.net, in our office, or we will be happy to mail or email a new form to you. Please note that the form must be witnessed by an unrelated person. Also, if you are vested and married, your spouse is the automatic beneficiary. You will need to complete a form and have your spouse's consent to name someone other than your spouse as the beneficiary. At the time of your retirement, you will be given the opportunity to designate a beneficiary for your pension benefit.

Almost Time to Retire?

If you are getting ready to retire, please contact our office to schedule a retirement appointment about 30 days before you plan to retire from Jefferson County. You can find a list of documents you will need at your retirement appointment in your Member Handbook or on our website, www.grsal.net.

You will also need to contact Human Resources at (205) 325-5249 to make an appointment to discuss your health, dental, and vision insurance options.
