# Becoming Eligible to Retire – Your 2nd Membership Milestone

The 2<sup>nd</sup> Membership Milestone is becoming eligible to retire. To retire and begin receiving your normal lifetime retirement benefit, you must meet one of the following service and / or age requirements:

- Thirty (30) years of paid service;
- Ten (10) or more years of paid service and age sixty (60)
- Thirty (30) years of service, twenty (20) years of which are paid service, and age fifty-five (55).

You should schedule a retirement appointment approximately thirty (30) days before you plan to retire. You may obtain a retirement appointment checklist in your member handbook or on our website, <a href="https://www.grsal.net">www.grsal.net</a>.

Do you need to retire before you are eligible for a normal retirement? You may be eligible for an early or 25-year early retirement benefit. These benefits are reduced to reflect that benefit payments begin before you are eligible under a normal retirement.
